Training Methodology:

To make training more practical and purposeful, the Institute adopts the following training methodology:

- Lecture-cum-discussion on concepts and practices of promoting/ strengthening cooperatives.
- Case studies, group discussions, role plays and simulation exercises for development of requisite competence.
- Intensive interaction with experts, cooperative entrepreneurs, behavioral scientists and trainer-motivators for gaining practical insight into cooperative development efforts.
- Field visits to good cooperative institutions, small/ micro enterprises and apex cooperative organizations to view things in process/ action.



Our Core Diploma and Sectoral programmes:

1. Higher Diploma in Cooperative Management (HDCM) (Regular):

It is a 36-weeks duration Diploma for Cooperative Dept/ Officers/ Personnel of Coop. Apex Bodies. Certificate will be awarded by National Council for Cooperative Training, New Delhi, Ministry of cooperation, Govt. of India.

2. Higher Diploma in Cooperative Management (HDCM) (Correspondence):

It is also a 36-weeks duration Diploma Programme through Distance Learning mode, made for the personnel of Cooperative Banks, PACS and other Coop. organizations. Freshers may also join this programme. Certificate will be awarded by National Council for Cooperative Training, New Delhi, Ministry of cooperation, Govt. of India.

3. Diploma in Agriculture Extension Services for Input Dealers (DAESI) :

After due approval from its SAMETI, West Bengal & MANAGE, Hyderabad, NSRICM has launched a Diploma in Agriculture Extension Services for Input Dealers Programme. It is a one year duration diploma programme.

4. Programmes for Directorate General of Resettlement (DGR):

The Institute is also conducting Training Programme for Defense personnel (JCOs/ORs) before their retirement. The duration of these Diploma/ Certificate programmes varies from 8 weeks to 16 weeks. These programmes are sponsored by DGR, Ministry of Defence, Govt. of India.

5. SOFTCOB Scheme Programme:

As C-PEC BIRD, accredited CTI, the institute will be conducting programmes for Cooperative Banks and PACS sponsored by NABARD.

6. Other programmes:

- Certificate Course on Computer Application, Duration 3- Months
- Computer training course on Tally, Duration 1-Month
- Course on GST, Income Tax on Salary TDS etc. Duration 3 – 5 days

Programmes for North-East:

Every year, since the responsibility has been assigned to the Institute for catering to the growing and diversified training needs of various sectors of Cooperative Movement of the North-East States like Sikkim and Tripura, which are under cooperatively underdeveloped and least developed category, the Institute is getting collaborative support for financing such programmes and could achieve the following landmarks:

*Every Year since the responsibility has been assigned, the Institute is catering to the growing and diversified training needs of Cooperative Movement of the North-Eastern States like Sikkim and Tripura.

*In order to strengthen the Cooperative Movement in the cooperatively least developed states like Sikkim and Tripura, the Institute undertook a feasibility study in Sikkim for establishment of State Cooperative Union and launched education programmes for non-officials and tailor-made Management Development Programmes in a massive scale. In addition, evaluation study was taken up to assess the performance of Cooperative Education Field Project run by NCUI, New Delhi.

*Institute is also taking care of the skill development aspect of departmental officers of Cooperative Directorate of these States by way of conducting need based training programmes.

Collaborative Programmes:

The institute also conducts training programmes in collaboration with various National Level organizations like NABARD, NCDC, MANAGE, SEBI, BSE, NIAM, WDRA, NFDB, NDDB etc.

In addition to these the institute offers need based training programmes for the cooperative banks, PACS and other organizations.

Target Group:

The programmes have been specifically designed for professionals involved in activities related to promoting cooperative development. It is, therefore, specifically suited to the following:

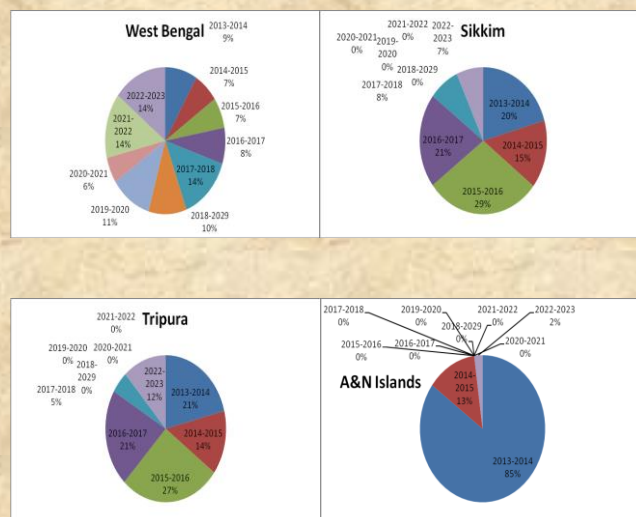
- Cooperative trainers-motivators.
